Gift Aid

Because Orinoco is a Registered charity we can claim tax relief on all donations we receive from UK tax payers. For each £10 membership payment we receive we can claim £2.80 from HMRC.

You must pay an amount of Income Tax and/or Capital Gains Tax at least equal to the tax that Orinoco reclaims on your donations in the appropriate tax year. (currently 28p for each £1 you give).

- * You can cancel this Declaration at any time by notifying Orinoco.
- * If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that Orinoco reclaims, you can cancel your declaration.
- * If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
